**DEPARTMENT ORDER**

**SUBJECT: Guidelines on the Utilization of the Fund Sub-Allotment from the funds of the Tuberculosis Control Program for the commemoration of the World TB Day on March 24, 2009.**

**I. Purpose of the Sub-Allotment**

The world commemorates **World TB Day** every March which is likewise annually celebrated in the Philippines with this year's local theme: **STOP TB: Kaya mo....Kaya ko.**

In line with this commemoration, the Department of Health through the 16 Centers for Health Development shall lead an advocacy and promotional activities along with other government agencies, NGOs, LGUs and stakeholders in their respective areas. Thus, this sub-allotment is done to augment funds of CHDs for the said event.

**II. Objective :**

To provide MOOE funds for the commemoration of the World TB Day on March 24, 2009.

**III. General Guidelines**

1. The Infectious Disease, NCDPC shall sub-allot a total amount of Two Million Five Hundred Thousand Pesos (P 2,500,000.00) from the TB Control Program Funds to cover expenses for the World TB Day commemoration in all **Centers for Health Development**, allocated as follows:



2. The CHD Director shall ensure that the persons-in charge of activities and the budget/accounting division are properly informed of these guidelines.
3. The CHD NTP Coordinator shall ensure the submission of the Post Activity and Liquidation Reports to the Finance Service, noted/approved by the CHD Director and copy furnished NCDPC, DOH, Manila;
4. In the event that funds will not be completely utilized, the remaining amount shall be used for activities related to NTP;
5. The disbursement of funds shall follow government accounting and auditing rules and regulations.
6. The funds shall be utilized or obligated on or before March 24, 2009
